- 1. Your undersigned acknowledges that I have voluntarily applied to participate in the sport of Bear hunting. I understand the activity of Bear hunting and all other hazards and exposures connected with the activities conducted in the outdoors involve certain real and unpredictable risks. I am cognizant of the risks and danger inherent with the activities in which I will be participating and achnowledge that I am fully capable of participating in the activites contracted for. I willingly assume the risk of injury as my responsibility, whether they are obvious or not obvious.
- 2. I understand and agree that any bodily injury, death or loss of personal property and expenses as a result of my negligence or the negligence of anyone participating in any scheduled or unscheduled activities are my responsibility. I also state and acknowledge that the activities associated with Bear hunting involve risks including, but not limited to, fall from a tree stand, attack by wild animals and other risks.
- 3. I acknowledge that accidents or illness can occur in remote places without medical facilities and that they may be aggravated by exposure to temperature extremes or inclement weather. In consideration of and as part payment for the right to participate in the Bear hunting activities and any other activities including the services of food that may be arranged for me by Jonathan Pearson, d/b/a Bear Busters Outfitters, and their agents and associations, agree that I am in good health with no physical defects that might be injurious to me and that I am able to handle the hazards of weather conditions, walking, climbing and all and any similar conditions associated with the activities of Bear hunting.
- 4. In consideration of being permitted to participate in the bear hunt conducted by Jonathan Pearson, d/b/a Bear Busters Outfitters, Releaser, for himself, his legal representavites, heirs and assigns, hereby releases, waives and discharges Jonathan Pearson, d/b/a Bear Busters Outfitters, Releasees, and all other owners and operators of the premises including use of any vehicles or equipment of the owners and all other respective agents and all other participants in the stated activities of and from all claims, demands, actions and causes of action of any sort, for injuries sustained to my person and/or property, even injury resulting in the death of the Releaser, during my presence on the premises and my voluntary participation in the stated activities of Bear hunting due to negligence or any other fault.
- 5. Releaser agrees to indemnify the Releasees and each of them from any loss, liability, damage or costs they may incur due to the presence of Releaser during the Bear hunt, whether caused by the negligence of the Releasees or otherwise.
- 6. Releaser hereby assumes full responsibility for the risk of bodily injury, death or property damage due to the negligence of Releaser, Releasees, or otherwise, while Bear hunting.

- 7. Releaser expressly agrees that this release, waiver and indemnity agreement is intended to be as broad and inclusive as permitted by the laws of the State of Minnesota, and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in the full force and effect.
- 8. This contact shall be legally binding upon me, my heirs, my estate, assigns, legal guardians, and my personal representative.
- 9. I have carefully read this Agreement and fully understand its contents. I am aware that I am releasing legal rights and that I otherwise may have and I enter into this contract on behalf of myself and of my own free will, and with full comprehension and awareness of the risks involved.
